



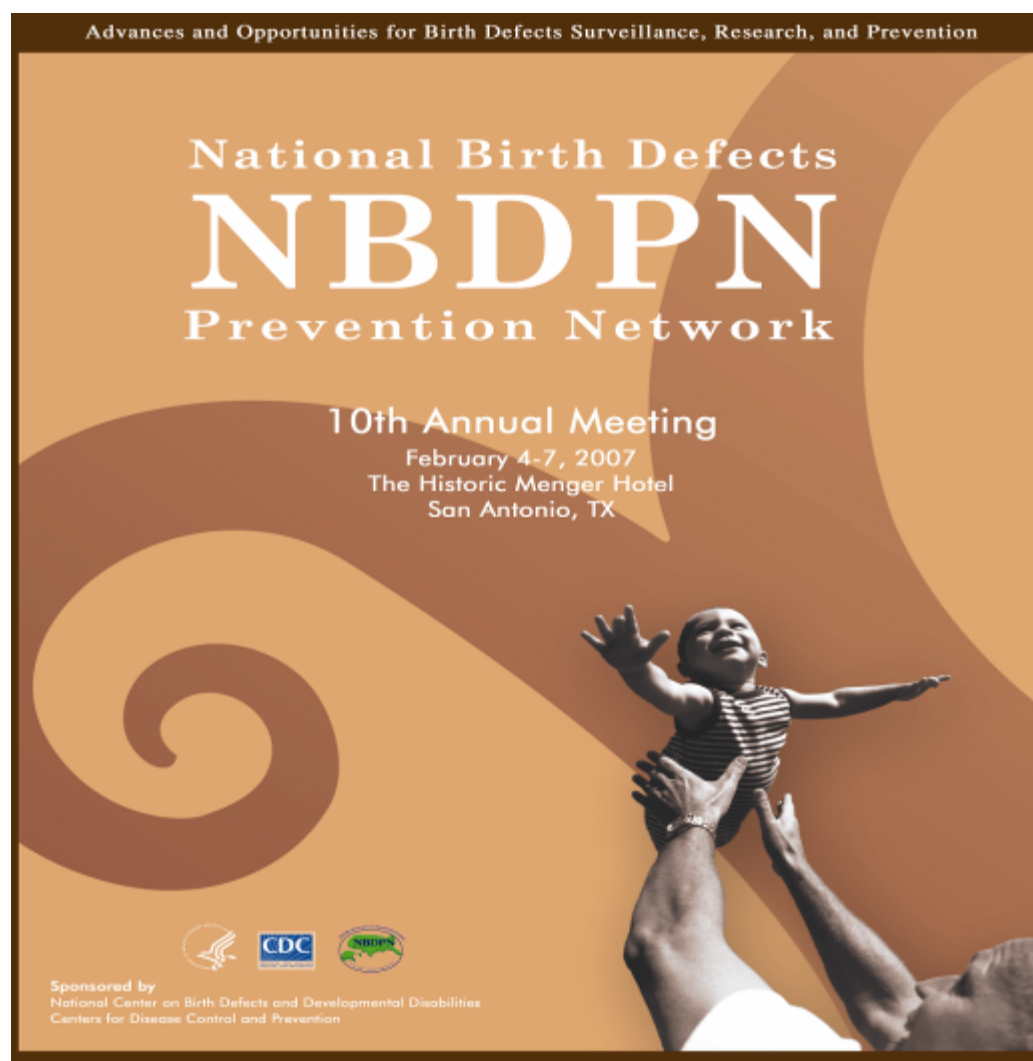

10th Annual NBDPN Meeting



On February 5, 2007 the NBDPN celebrated its **10th Annual Meeting** at the Menger Hotel in San Antonio, Texas. A record-popping 264 participants from all 50 states, as well as Puerto Rico and Canada countries attended, including 90 who had never been to an NBDPN meeting. Professional roles represented in the following proportions:

- Birth Defects Program Manager 23%
- Surveillance Staff/Abstractor 27%
- Other Public Health 17%
- Clinical Medicine 3%
- Academics/Research 19%
- Other 12%

Evaluations were overwhelmingly positive; the most highly rated sessions were:

- Embryology of the Heart and Associated Malformations (Thomas Sadler)
- Family/Individual Perspectives on Heart Defects (Sheryleen Grothus and Wesley Ledoux)
- Syndromes Associated with Heart Defects (Angela Lin and Tiffany Riehle Colarruso)
- Are amphibians canaries? What frogs may be telling us about pesticides and birth defects (Tyrone Hayes)

Other popular sessions included Prenatal Diagnosis Surveillance Methods, Monitoring for Changes in Birth Defects Prevalence, and The Heart of Surveillance: Tips on Coding.

Welcome NACCHO!

The National Association of County and City Health Officials (NACCHO) Birth Defects and Developmental Disabilities Project is funded by the Centers for Disease Control and Prevention. Since August 15, 2005, the BDDD project has provided information and analyses on the prevention of birth defects and developmental disabilities to local health officials and programmatic staff. The goal of the project is to assist local health departments in the effective delivery of services and health promotion messages to prevent birth defects and developmental disabilities.

Project staff began working with NBDPN last fall to develop a query to understand the relationship between state and local health departments in birth defects surveillance, research, and prevention. Results from this survey were shared during a breakout session at the NBDPN Annual Meeting.

This breakout session also included a discussion around state and local collaboration in birth defects prevention and referral efforts. An overview of two state and local partnerships was given. Sangamon County, Illinois Department of Public Health, and the New Jersey Department of Health were featured.

NACCHO's Birth Defects and Developmental Disabilities projects sponsored six local health department representatives to attend the NBDPN Annual Meeting in San Antonio, TX and share their experiences during the breakout session. The scholarship recipients were chosen because of their demonstrated commitment to collaboration with their state health department in birth defects prevention and referral activities.

The scholars were: Karen Ayala, Winnebago County, IL; Alvina Eineke, Kane County, IL; Lois Eisenbret, Akron, OH; Tracey Sloat, Maricopa County, AZ; Jeanne Sloan, Monroe County, NY; and Allie Stender-Mrazek, Coconino County, AZ.

Presidents Award

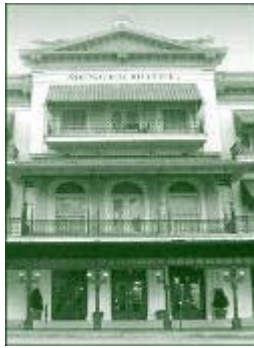
Honors an NBDPN member who has made significant contributions important to the mission and goals of the NBDPN.
