Mission

The National Birth Defects Prevention Network (NBDPN) is a group of individuals involved in birth defects surveillance, research, and prevention. It was created to establish and maintain a national network of state and population-based programs for birth defects surveillance and research. The Network assesses the impact of birth defects upon children, families, and health care; identifies factors that can be used to develop primary prevention strategies; and assists families and their providers in secondary disabilities prevention.

Goals

- Improve access and application of information about the prevalence and trends of birth defects
- Increase collaboration between members within the birth defects community
- Advance science through birth defects surveillance and its application to public health efforts and resource allocation



Background

The National Birth Defects Prevention Network, a membership organization founded in 1997, became a 501 (c) (3) nonprofit organization in September of 2000. The Network's leadership developed the original strategic plan in 2005. The revision process began with a team of eighteen Steering and Advisory group members, a CDC Liaison, and a professional nonprofit facilitator.

Strategic planning took into consideration the results of the prior five year plan; the knowledge and experience of NBDPN leadership and key stakeholders; and the internal and external environment. An environmental scan was conducted with the help of PRQuickhelp Consulting, administrative support from the Centers for Disease Control and Prevention, and other strategic planning group members.

And the beat goes on....

...looking to the future for healthy hearts

Each year, the National Birth Defects Prevention Network prepares a template of materials, working with healthcare professionals and public health agencies around the country to encourage prevention and awareness. In 2012, the focus was congenital heart defects.



Congenital heart defects include abnormalities of the heart that are present at birth. Some have only a minor and brief effect on a baby's health and some have very serious and life-long effects. Nearly 40,000 cases (approximately 1 in 110 live births) are reported annually in the US. Public awareness, accurate diagnosis, and expert medical care are all essential for adequate prevention and management of these all too common and deadly conditions.

Surveillance Standards and Guidelines

The Network established the Surveillance Guidelines and Standards Committee (SGSC) in order to develop standards and guidelines for birth defects surveillance and promote their use by programs nationally. The *NBDPN Guidelines for Conducting Birth Defects Surveillance* were published in 2004 with the overarching long-term objectives of:

- Improving the quality of data (accuracy, comparability, completeness, and timeliness)
- Enhancing the utility of data for research on the distribution and etiology of birth defects
- Promoting the use of data for linking affected children with services and for evaluation of access to services

Birth defect surveillance standards are a priority for the NBDPN and development has been assigned to the SGSC. Standards will:

- Demonstrate the unique value of these surveillance systems to generate quality data on birth defects
- Help states advocate for additional resources to improve their systems



- Produce better national estimates and meaningful comparisons across regions
- Facilitate state collaborations
- Prepare surveillance systems for the future (e.g., electronic health records and ICD-10)

To address this priority, the SGSC formed a Birth Defects Standards Steering Committee to develop draft standards. The draft standards have two components (data quality and data utilization). Data quality represents the foundation of our programs and data utility demonstrates the value of birth defects surveillance systems. The committee has developed an assessment tool structure that state programs can use to assess their performance against the standards. After additional refinement and pilot testing, the SGSC will integrate these standards into the Birth Defects Surveillance Guidelines document thus producing one cohesive document that includes both standards and guidelines.


NBDPN Member Organizations 2012

NBDPN Partners

The NBDPN has established relationships with many organizations which have a compatible mission. The Centers for Disease Control and Prevention (CDC) and the March of Dimes Foundation (MOD) are NBDPN associate members. As such, they are represented on the Networks' Executive Committee. These associates play a crucial role in developing and advancing Network objectives. NBDPN collaborated with various partners on key activities in 2012.

The American Academy of Pediatrics worked closely with the NBDPN on several initiatives including: joint webinars focused on birth defects; development, dissemination and promotion of Birth Defects Prevention Month materials; education of providers on critical congenital heart defect (CCHD) screening; and development of strategies to increase awareness and promote folic acid use for neural tube defect (NTD) recurrence prevention.

The MOD, the Association of Maternal and Child Health Programs (AMCHP), the Network and others developed communication materials to be used for advocacy efforts regarding legislative funding and appropriations.

The Teratology Society, which publishes the NBDPN Annual Report in Birth Defects Research-Part A, played a critical role in disseminating prevention information in their special issue published in December 2012.

Parent Advisory Group

Parents of children with various conditions participate, providing insight and guidance regarding family and individual needs and the relevance of Network activities. In 2012, this group worked closely with the Utah Birth Defect Network, CDC, and NBDPN to develop the Network family extension website at endbirthdefects.org, debuting in January 2013.

NBDPN, Inc. Financial Report 2011

NBDPN, Inc. is a 501(c)3 non-profit organization that is incorporated in Delaware. NBDPN, Inc. is an allvolunteer organization without a centralized office. Operations are distributed among volunteer members nationally.

In the 2011 fiscal year (Jan-Dec), NBDPN received 73% of its revenue from the Annual Meeting and 87% of the expenses were related to the Annual Meeting. Revenue from membership dues in 2011, the first year of paid membership, was 9%.


2011 Revenues

2011 Expenses




