- In July, 2004, the *National Center on Birth Defects and Developmental Disabilities, Centers for Disease Control and Prevention (CDC), in coordination with the National Task Force on Fetal Alcohol Syndrome and Fetal Alcohol Effect*, released the publication, *"Fetal Alcohol Syndrome: Guidelines for Referral and Diagnosis."* The primary goal of these guidelines is to provide standard diagnostic criteria for FAS so that consistency in the diagnosis can be established for clinicians, scientists, and service providers. The guidelines are based on state-of-the-art scientific research, clinical expertise, and family input regarding the physical and neuropsychological features of FAS. In addition, guidance about medical, educational, social, and family services appropriate for individuals with FAS and their families is reviewed.
